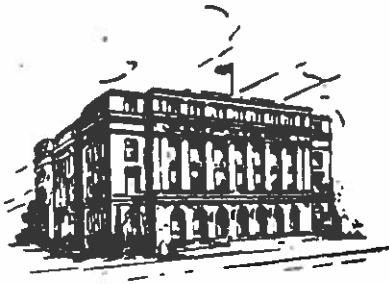

### SCIOTO COUNTY BOARD OF HEALTH RESOLUTION 1-02

- **Whereas, Amended Senate Bill 136 became law on the 21st of November 2001 and;**
- **Whereas, this new law requires local Boards of Health to conduct an annual cost methodology for determining license fees for the food service and food establishment program, and;**
- **Whereas, the cost methodology, once completed, requires 3 readings at regularly scheduled monthly Board meetings and a public hearing held between the second and third reading and;**
- **Whereas, the Scioto County Board of Health gave a first reading at its regularly scheduled Board meeting on October 26, 2001 and;**
- **Whereas, the Scioto County Board of Health gave a second reading at its regularly scheduled Board meeting held November 30, 2001 and;**
- **Whereas, a public hearing on the license fees schedule was held on December 7, 2001 and;**
- **Now, therefore, be it resolved this 18th day of January 2002, the Scioto County Board of Health gives a third reading and passes the license fees schedule for the 2002 licensing period for food services and food establishments as follows;**






