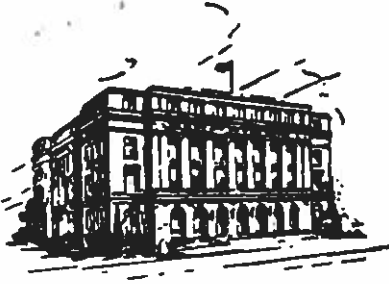

- Whereas, the Ohio Department of Health, Division of Prevention, Bureau of Environmental Health has made available to the 88 counties in the State of Ohio a grant totalling \$11,158,150.00 and;
- Whereas, no more than one project will be funded per county, and;
- Whereas, the grant titled Public Health Infrastructure will address bioterrorism, other outbreaks of infectious disease, and other public health threats and emergencies at the county and regional public health level and;
- Whereas, qualified applicants must have a full-time administrative triad to include a full-time health commissioner, a full-time Director of Nursing and a full-time Environmental Health Director, and;
- Whereas, the full-time administrative triad cannot be less than 3 full-time employees and;
- Whereas, local health departments may partner with other health jurisdictions to meet the triad requirements and;
- Whereas, the Scioto County Board of Health and Portsmouth City Board of Health have worked well together in past bioterrorism and other public health threats and emergencies and have trained together for the events and;
- Whereas, the Scioto County Board of Health does not current meet the administrative triad as required by the Ohio Department of Health for the Public Health Infrastructure grant;
- Now, therefore be it resolved this 28th day of June, 2002, the Scioto County Board of Health agrees to partner with the Portsmouth City Board of Health and apply for the Public Health Infrastructure grant totaling \$110, 671.00.




