SCIOTO COUNTY BOARD OF HEALTH RESOLUTION MAY 2003

- *Whereas, the Scioto County Health Department is required by the Ohio Administrative Code to conduct cost methodologies for determining license fees for the Mobile Home Park, Swimming Pool, Campground, Resident Camp, Private Water System, Sewage Installation, Sewage Installer, Pre-Site Sewage Evaluation, Sewage Loan Inspection and Water Sample Programs and;*
- *Whereas, the cost methodology, once completed, requires 3 readings at regularly scheduled monthly Board of Health meeting with a public hearing held between the second and third reading with a 30 day notification given to all affected by the proposed fee changes prior to the public hearing and;*
- *Whereas, the Scioto County Board of Health gave a first reading to the proposed fee changes at its regularly scheduled meeting held January 24, 2003 and;*
- *Whereas, the Scioto County Board of Health gave a second reading to the proposed fee changes at its regularly scheduled meeting held February 28, 2003 and;*
- *Whereas, public notice was mailed 30 days prior to a public hearing held April 18, 2003 at 9:30am at the Scioto County Board of Health and;*
- *Whereas, the Scioto County Board of Health gave a third reading to the proposed fee changes after the public hearing on April 18, 2003 and passed the proposed fee changes as follows:*
