RESOLUTION

WHEREAS, thousands of innocent Americans and rescue workers were killed and injured as a result of these cowardly, terrorist attacks;

WHEREAS, the spirit of the American people cannot be suppressed or divided by terrorist acts,

WHEREAS, in support of public pride and unity, the Scioto County Commissioners declare September 18, 2001 as Ohio County Government National Support Day;

WHEREAS, the Scioto County Commissioners are eternally grateful for the faithful efforts of rescue workers to save and protect fellow Americans;

THEREFORE BE IT RESOLVED, that the Scioto County Commissioners condemn the invasion of these terrorists in the United States of America, and;

BE IT FURTHER RESOLVED, that the Scioto County Commissioners support and entrust President George W. Bush, the Members of Congress, the National Security Council and the Armed Services to defend our liberties and protect the United States of America around the world against additional attacks, find the perpetrators, and bring them to justice, and;

BE IT STILL FURTHER RESOLVED, that the Scioto County Commissioners recommends that the citizens of Scioto County to support relief efforts by giving blood to the American Red Cross.
