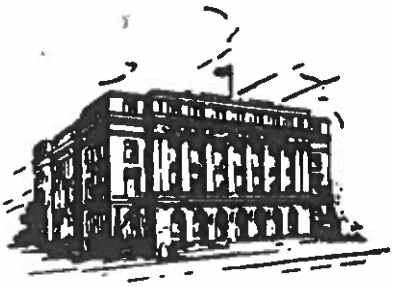
--- Whereas, federal and state governments are mandating more programs every year to be implemented by local boards of health and;
