-WHEREAS, THE SCIOTO COUNTY BOARD OF HEALTH IS REQUIRED BY THE OHIO ADMINISTRATIVE CODE TO CONDUCT COST METHODOLOGIES FOR DETERMING LICENSE FEES IN THE TATTOO AND BODY PIERCING INSPECTION AND LICENSING PROGRAM AND;

-WHEREAS, THE COST METHODOLOGY, ONCE COMPLETED, REQUIRES 3 READINGS AT REGULARLY SCHEDULED MONTHLY BOARD OF HEALTH MEETINGS WITH A PUBLIC HEARING HELD BETWEEN THE SECOND AND THIRD READING WITH A 30 DAY NOTIFICATION GIVEN TO ALL AFFECTED BY THE PROPOSED FEE CHANGES PRIOR TO THE PUBLIC HEARING AND;

-WHEREAS, THE SCIOTO COUNTY BOARD OF HEALTH GAVE A FIRST READING TO THE PROPOSED FEE CHANGE AT ITS REGULARLY SCHEDULED MEETING HELD NOV. 21ST, 2003 AND;

-WHEREAS, THE SCIOTO COUNTY BOARD OF HEALTH GAVE A SECOND READING TO THE PROPOSED FEE CHANGE AT ITS REGULARLY SCHEDULED MEETING HELD DEC. 5, 2003 AND;

-WHEREAS, A PUBLIC NOTICE WAS MAILED 30 DAYS PRIOR TO A PUBLIC MEETING HELD JAN. 28, 2004 AT 10:00 A.M. AT THE SCIOTO COUNTY BOARD OF HEALTH AND;

-WHEREAS, THE SCIOTO COUNTY BOARD OF HEALTH RECEIVED NO COMMENTS AT THE PUBLIC HEARING ON A COST REDUCTION IN THE LICENSE FEE PROGRAM FOR THE TATTOO AND BODY PIERCING PROGRAM AND;

-WHEREAS, THE SCIOTO COUNTY BOARD OF HEALTH HAS GIVEN A THIRD READING TO THE PROPOSED FEE CHANGE IN THE TATTOO AND BODY PIERCING PROGRAM ON FEB. 23, 2004 AND;

-THEREFORE, BE IT RESOLVED THIS 27TH DAY OF FEBRUARY 2004 THE SCIOTO COUNTY BOARD OF HEALTH ADOPTS THE NEW LICENSE FEE SCHEDULE FOR THE TATTOO AND BODY PIERCING PROGRAM EFFECTIVE MARCH 31, 2004 AS FOLLOWS;




