Scioto County Board of Health Resolution – EH – 22-6

Public Swimming Pools and Spas – Chapter 3749 of the Ohio Revised Code Ohio Administrative Code Rule 3701-31-03; 3701-36-14 **Public Swimming Pools and Spas Program Cost Methodology and Fees** 

Ohio Administrative Code Section 3701-31-03 Rule (D) (1), (2), (3) and (4) - License Fee Categories established

Whereas, No person shall operate or maintain a public swimming pool, public spa, or special use pool without a license issued by the licensor having jurisdiction per Ohio Revised Code Section 3749.04 (A); and

Whereas, Ohio Revived Code Section 3749.04 (B) states every person who intends to operate or maintain an existing public swimming pool, public spa, or special use pool shall, during the month of April of each year, apply to the licensor having jurisdiction for a license to operate the pool or spa. Any person proposing to operate or maintain a new or otherwise unlicensed public swimming pool, public spa, or special use pool shall apply to the licensor having jurisdiction at least thirty days prior to the intended start of operation of the pool or spa. Within thirty days of receipt of an application for licensure of a public swimming pool, public spa, or special use pool, the licensor shall process the application and either issue a license or otherwise respond to the applicant regarding the application; and

Whereas, the Ohio Administrative Code Rule 3701-31-03(C) states each licensor shall utilize the cost methodology specified in rule 3701-36-14 of the Administrative Code to calculate fees for providing services specified in section 3749.04 of the Revised Code. The calculated fees shall not exceed the cost of licensing and inspection public swimming pools; and

Whereas, the Ohio Administrative Code Rule 3701-31-03(C)(1) states 3749.04 (E) states, all license fees collected by a licensor shall be deposited into the public swimming pool fund created by division (E) of section <u>3749.04</u> of the Revised Code in each health district.

Whereas, Section 3701-31-03 (D)(1)(2)(3) and (4) designates license fees established by a licensor pursuant to section 3709.09 of the Revise Code for a public swimming pools shall be specified in accordance with the following categories:

(1) Individual Public Swimming Pools;

- (2) Individual Public Spas;
- (3) Individual Special Use Pools;
- (4) Individual and Additional Licenses. Each individual public swimming pool shall be issued an individual license based on the categories listed above. Facilities where multiple public swimming pools are located at the same address, the licensor may establish a reduced fee for each additional license.

Therefore, Be It Resolved with the first reading of this Resolution on July 8, 2022; a public hearing held August 11, 2022; a second reading on August 12, 2022 and a third and final reading on September 9, 2022 the attached fees and fee categories will be adopted and effective as of this date.
