### SCIOTO COUNTY BOARD OF HEALTH RESOLUTION

#### 2022 RETAIL FOOD PROGRAM FEES

### January 14, 2022

- Whereas, the Scioto County Board of Health is required by the Ohio Administrative Code to conduct an annual cost methodology of the Retail Food Program and;
- Whereas, the cost methodology completed in November 2021 requires for the decrease of license fees for all Risk Levels Commercial and Non-Commercial, Mobiles, Vending, Temporaries, and;
- Whereas, the proposed license fee adjustments require three readings at regularly scheduled monthly Board of Health meetings with a public hearing held at least 20 days after giving written notice of the hearing to all persons or government entities holding a retail food license, and;
- Whereas, the Scioto County Board of Health gave a first reading to the proposed fee changes at its regularly scheduled meeting on November 12, 2021 and;
- Whereas, the Scioto County Board of Health gave a second reading to the proposed fee changes at its regularly scheduled meeting held December 10, 2021 and;
- Whereas, public notice was given on November 17, 2021 at least 20 days prior to a public hearing held on December 16, 2021 and;
- Whereas, the Scioto County Board of Health gave a third reading to the proposed fee changes on January 14, 2022 and passed the proposed fee changes as follows:
