— Whereas, on this 20th day of May 2005, the Scioto County Board of Health has approved the continued partnership with the Portsmouth City Board of Health on the Public Health Infrastructure Grant to be administered by the Portsmouth City Health Department and;


— Whereas, the Portsmouth City Board of Health and the Scioto County Board of Health will partner with Pike County, Lawrence County, and Ironton City Health Districts to establish a health jurisdiction with a maximum 200,000 population according to the 2000 Census so as to continue to employ a full-time epidemiologist, who will be responsible for rapid identification of diseases and initiate prevention and control activities for response to bioterrorism, other outbreaks of infectious disease, and other public health threats and emergencies and;

— Whereas, heretofore, this partnership shall be referred to as Sub Region I, and shall include Portsmouth City, Scioto County, Pike County, Lawrence County and Ironton City Health districts and;

— Therefore, Be it Resolved this 20th day of May 2005, the Scioto County Board of Health supports the continuation of being the contact agency for the purpose of maintaining a full-time epidemiologist, to be funded from the Public Health Infrastructure Grant received by each partner within the Southeast Region I.


