Resolution for the Amendment of the *Operation and Maintenance Program for Household Sewage Treatment Systems March 10, 2023. (E-01-23)*

Formerly known as:

(Operation and Maintenance Program for On-Lot Home Septic Systems June 19, 2015 (01-15)

WHEREAS, an Operation and Maintenance Program for Household Sewage Treatment Systems is required to be implemented in all health jurisdictions within Ohio as in accordance with Section 3701-29-09(I) of the Ohio Administrative Code, and;

WHEREAS, The Scioto County Health Department will continue to enter all new, altered and replacement systems within the program, adding older home systems into the program over time, and;

WHEREAS, the Scioto County Health Department will allow registered service providers in Scioto County to monitor and inspect the systems within the required time period. The Health Department will issue renewals to homeowners for their Household Sewage Treatment System Operation & Maintenance Permit. (HSTS O&M Permit) and;

WHEREAS, the Board of Health has approved for registered service providers to inspect, monitor and collect samples for National Pollutant Discharge Elimination System (NPDES) annual sampling requirements in accordance with protocols established by Ohio EPA and;

WHEREAS, there will be no fee for enrollment into the Operation and Maintenance Program, and;

WHEREAS, the HSTS O&M Permit renewal frequency shall be every 5 years for all system types, and;

WHEREAS, the HSTS O&M Permit renewal requirements shall be:

1. Completion of a renewal application.
2. Demonstration of O&M by providing at least one System Service Report or Inspection Report signed by a service provider registered in Scioto County per renewal period.
3. Payment of a renewal fee of \$50.00.
4. Submission of all required O&M records.
5. The owners of an HSTS with a pretreatment component (aeration or otherwise) or discharging system that receives coverage under the General NPDES Permit is required to maintain a service contract for the life of the system. The service contractor must be registered in Scioto County and be certified by the applicable equipment manufacturer.
